If you have members who wish to be part of the RMPA contingent at the RBL Muster on Remembrance Sunday please do get them, if they have not already done so, to email Bob Potts with their interest and details – we need ideally to get 75 names however if we can only achieve 50 then that will have to do, the consequence is that we will be cut in our allocation by the RBL for future years, the reason being that Whitehall has a total capacity in terms of safety and event security and control – each veteran place is therefore counted in the overall figures, if the RBL can cut soe contingents due to lack of uptake then they will.
